## I need help with sexual harassment, sexual violence, or other human rights violations



Visit our Human Rights and Sexual Harassment-Sexual Violence Counseling Center

### What kind of counseling is offered?

#### Sexual Harassment, Sexual Violence

Sexual violence crimes including rape and indecent act, sexual harassment (verbal, physical, visual), stalking etc.

#### Human Rights Violations

Human rights violations occurring on campus including discrimination based on prohibited grounds such as race and disability, unfair treatment, and verbal abuse.

### What kind of help can I get?

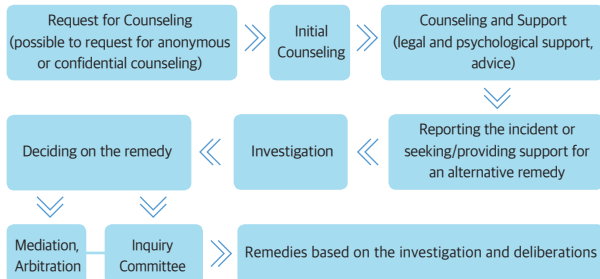
- Measures to prevent further violations (no contact order, separation of parties)
- Supporting rehabilitation (psychological support, legal consultation, advice on coping with the case etc.)
- Seeking solution to resolve the case (mediation & arbitration, investigation, disciplinary action, alternative solution, etc.)
- Raising awareness of the perpetrator and preventing recurrence (apology, education, volunteer work etc.)

### Who are eligible for our counseling service?

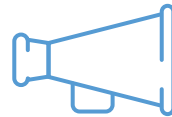
All members of SNU, including students, faculty, and administrative staff, can seek help from the SNU Human Rights Center. It is also possible to seek help when any of the alleged wrongdoers or the victims is a member of SNU.

### How can I get help and what are the procedures I need to follow?

You can ask for the help you need by contacting us through e-mail or phone, or by visiting the center. Please contact us in advance to arrange an appointment before you visit the center.

#### Open Human Rights Lecture Series

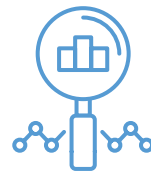
Lecture series on human rights theories and issues open to students and the public (July)
